Subject: RESOLUTION NO. 22-50, APPROVING AN EXPENDITURE TO HUSKY CREATIVE IN THE AMOUNT OF \$3,051.75 FOR PHASE 2 BANNERS FOR THE DAONO MUSIC AND SPIRITS FESTIVAL

Background: Resolution 22-50, approves an expenditure of \$3,051.75 to Husky Creative for the production of Phase 2 banners for the Daono Music & Spirits Festival. The City is spending additional money on banners this year due to the festival name change from the Carbon Valley Music & Spirits to the Daono Music and Spirits. Several of the banners will be reused for future festivals so the cost should significantly decrease in future years. The total cost of banners for 2022 will be \$10,886.25, which includes the expenditure of \$7,834.50 that Council approved at the June 27th meeting.

Recommended Action: Staff recommends approval of Resolution 22-50.

RESOLUTION NO. 22-50

A RESOLUTION APPROVING AN EXPENDITURE TO HUSKY CREATIVE IN THE AMOUNT OF \$3,051.75 FOR BANNERS FOR THE DACONO MUSIC AND SPIRITS FESTIVAL

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DACONO, COLORADO:

Section 1. The proposal by and between the City of Dacono and Husky Creative for Phase 2 of the music festival banners is hereby approved in essentially the same form as the copy of such proposal accompanying this resolution. The City Council hereby authorizes the expenditure of the funds as necessary to meet the terms and obligations of the proposal.

Section 2. The Mayor is hereby authorized to execute the Agreement on behalf of the City, and is further authorized to negotiate and approve on behalf of the City such revisions to the Agreement as the Mayor determines are necessary or desirable for the protection of the City, so long as the essential terms and conditions of the Agreement are not altered.
