Background: Resolution 23-56 updates Exhibit A, hourly rate schedule, of the engineering services contract between the City of Dacono and Lamp Rynearson & Associates, Inc.

RESOLUTION NO. 23-56

A RESOLUTION APPROVING AN AMENDMENT TO EXHIBIT A TO SECOND AMENDMENT TO AGREEMENT BY AND BETWEEN THE CITY OF DACONO, COLORADO, AND LAMP RYNEARSON & ASSOCIATES, INC., FOR ENGINEERING SERVICES

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DACONO, COLORADO:

WHEREAS, by Resolution No. 18-05 adopted on January 8, 2018, the City Council approved an Agreement By and Between the City of Dacono and Lamp Rynearson & Associates, Inc. for Engineering Services with hourly rates for services set forth in Exhibit A thereto; and

WHEREAS, by Resolution No. 21-26 adopted on May 24, 2021, the City Council approved a Second Amendment to Agreement By and Between the City of Dacono and Lamp Rynearson & Associates, Inc. with hourly rates for engineering services set forth in Exhibit A thereto; and

WHEREAS, the City Council desires to amend the Second Amendment to replace Exhibit A to the agreement to reflect the current hourly rates, effective June 1st, 2023-May 31, 2024, for services by Lamp Rynearson & Associates, Inc.

Section 1. The Second Amendment By and Between the City of Dacono and Lamp Rynearson & Associates, Inc. is hereby amended to replace Exhibit A with that version that accompanies this resolution.

Section 2. The Mayor is hereby authorized to execute Exhibit A, and is further authorized to negotiate and approve on behalf of the City such revisions to Exhibit A as the Mayor determines are necessary or desirable for the protection of the City, so long as the essential terms and conditions of the Second Amendment are not altered.

Travel Costs

Automobile mileage shall be charged at the maximum IRS employee reimbursables rate per mile. Travel costs, such as airfare, hotel and rental cars, shall be chargeable at actual cost plus 15% to cover general overhead and administration.

Materials

All materials other than normal office supplies which are used by Lamp, Rynearson & Associates, Inc., in connection with the rendering of services shall be chargeable at actual cost plus 15% to cover general overhead and administration.

Reproductions and Plots

All reproduction and plotting work performed by Lamp, Rynearson & Associates, Inc., shall be charged at the locally accepted commercial rate for such work. All outside photographic and direct-process reproduction costs advanced by Lamp, Rynearson & Associates, Inc., in connection with the rendering of services shall be charged at actual cost plus 15% to cover general overhead and administration.

Filing Fees and Other Costs Advanced

All filing or permit fees and other similar outside costs which are advanced or paid by Lamp, Rynearson & Associates, Inc., shall be chargeable at actual cost plus 15 percent to cover general overhead and administration.

Periodically, this schedule may be revised and updated by Lamp, Rynearson & Associates, Inc., who reserves the right to substitute the new miscellaneous charges schedule upon 30 days' notice.
