

ORDINANCE NO. 882

**AN ORDINANCE AMENDING THE CITY OF DACONO HOME RULE
CHARTER REGARDING POSTING NOTICES OF REGULAR CITY
COUNCIL MEETINGS**

WHEREAS, by Ordinance No. 851 adopted on August 13, 2018, the City Council referred to the City's voters a ballot question seeking authorization to amend the City's Home Rule Charter to allow notices of public meetings be posted at City Hall and on the City's website, which ballot question was approved; and

WHEREAS, pursuant to this authority approved by the City's voters, the City Council finds the City's Home Rule Charter should be amended as set forth herein.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE
CITY OF DACONO, COLORADO:**

Section 1. Section 3-1 of the City of Dacono Home Rule Charter is hereby amended to read as follows (words to be deleted ~~stricken~~; words to be added underlined):

Sec. 3-1. Meetings.

(a) The Council shall meet regularly. The Council shall prescribe by rules of the Council the day and hour of its regular meetings and the procedure governing meetings. Notice of regular meetings shall be posted at City Hall and on the City's website. The first meeting, regular or special, following each regular municipal election shall be the organizational meeting.

(b) The Council shall cause written minutes of its regular and special meetings to be taken and retained in the records of the City.

Section 2. If any article, section, paragraph, sentence, clause, or phrase of this ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the validity or constitutionality of the remaining portions of this ordinance. The City Council hereby declares that it would have passed this ordinance and each part or parts hereof irrespective of the fact that any one part or parts be declared unconstitutional or invalid.

Section 3. The repeal or modification of any provision of any prior ordinance by this ordinance shall not release, extinguish, alter, modify, or change in whole or in part any penalty, forfeiture or liability, either civil or criminal, which shall have been incurred under such provision, and each provision shall be treated and held as still remaining in force for the purpose of sustaining any judgment, decree, or order which can or may be rendered, entered, or made in such actions, suits, proceedings, or prosecutions.


Section 4. All other ordinances or portions thereof inconsistent or conflicting with this ordinance, or any portion hereof, are hereby repealed to the extent of such inconsistency or conflict.
