ORDINANCE NO. 888

AN ORDINANCE ZONING PROPERTY ANNEXED TO THE CITY OF DACONO AND KNOWN AS THE DACONO STATION ANNEXATION

WHEREAS, there has been submitted to the Planning and Zoning Commission of the City of Dacono a request for approval of initial zoning of R-1 Residential District and Planned Unit Development for property annexed to the City and known as the Dacono Station Annexation; and

WHEREAS, the City Council provided notice of the public hearing on said zoning by publication as provided by law; and

WHEREAS, no protests were received by the City pursuant to C.R.S. § 31-23-305; and

WHEREAS, the R-1 and PUD zoning classifications sought by the landowner are consistent with the City's plan for the area encompassed by the Dacono Station Annexation; and

WHEREAS, the Dacono Planning Commission has held a public hearing on the landowner's zoning request and voted not to recommend the requested zoning,, and the City Council has duly considered that recommendation.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DACONO, COLORADO:

Section 1. That 34.00 acre parcel shown as Tract 1 of the PUD map for Dacono Station, the legal description of which is set forth in Exhibit A and which parcel is shown on that PUD map attached hereto as Exhibit B, is hereby zoned Planned Unit Development ("PUD"). Uses within the PUD are limited to:

- 1. A compressor station including all equipment, buildings, and associated piping necessary for the safe and effective operation of the facility.
- 2. Compressor facility storage area, providing storage for various oil and gas support services, equipment, compression equipment and piping.
- 3. Communication tower and additional supporting communication equipment.
- 4. Electrical equipment needed to provide power to the associated communication equipment.
- 5. Pipelines and associated pipeline appurtenances necessary for the transportation of various types of hydrocarbons and water.

Section 2. That 266.49 acre parcel that is shown as Tract 2 and that 1.76 acre parcel shown as Tract A of the PUD map for Dacono Station, the legal descriptions of which are set

forth in Exhibit A and which parcels are shown on that PUD map attached hereto as Exhibit B, are hereby zoned R-1 Residential District.
