

**ORDINANCE NO. 803**

**AN ORDINANCE RENAMING A PORTION OF GRADEN BOULEVARD  
TO SPEEDWAY BOULEVARD**

**WHEREAS**, by Ordinance 719 adopted on August 25, 2001, the City Council renamed Weld County Road 10 “Graden Boulevard”; and

**WHEREAS**, the Mayor and City Council wish to honor Colorado National Speedway, which is celebrating its 50<sup>th</sup> racing season this year, by renaming a portion of “Graden Boulevard” to “Speedway Boulevard”; and

**WHEREAS**, the City Council finds that honoring Colorado National Speedway in this manner in recognition of its 50<sup>th</sup> racing season will enhance the Speedway’s community identity within the City and recognize it as a long-standing, thriving business of the City.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DACONO, COLORADO:**

**Section 1.** The portion of the public street known as “Graden Boulevard” running in a generally eastern direction from the I-25 E. Frontage Road and terminating at Colorado Boulevard, which portion is approximately 2 miles in length, and as located within the territorial boundaries of the City of Dacono, County of Weld, State of Colorado is hereby renamed, and shall hereafter be known as “Speedway Boulevard.”

**Section 2.** If any article, section, paragraph, sentence, clause, or phrase of this ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the validity or constitutionality of the remaining portions of this ordinance. The City Council hereby declares that it would have passed this ordinance and each part or parts hereof irrespective of the fact that any one part or parts be declared unconstitutional or invalid.


**Section 3.** All other ordinances or portions thereof inconsistent or conflicting with this ordinance or any portion hereof are hereby repealed to the extent of such inconsistency or conflict.
