City of Dacono Policy and Procedure for Grants to Community Organizations

Purpose

The purpose of this policy is to set a uniform policy and process by which community organizations may obtain financial and in-kind participation in support of projects, programs, and events.

Limitations and Special Provisions

The City Council has certain fiscal limitations on the amount of municipal funds it can set aside for donations to community projects. The aggregate amount is set aside by the City Council during the annual budget preparation process. This amount may vary from budget year to budget year according to priorities and available revenues.

The City is precluded from donating funds to any religious organization.

Depending upon the characteristics of the project or event, the City's participation may necessitate that appropriate insurance coverage be provided by the applicants.

Eligibility

Eligibility is restricted to applicants which are recognized community service organizations, organized and federally designated for tax purposes as non-profit corporations, or organized school groups.

Award Criteria

All applications for municipal donations will be reviewed based upon how well the stated purpose for the donation request serves the City's citizens in relation to any or all of the following general criteria:

- Promotion of commerce and industry
- Celebration of the City's culture or history
- Observance of local, regional, or national historic dates or events
- Contribution to the general public good in areas of education, safety, health, welfare, or recreational activities
- Expected number of people who will participate or benefit from the program, event, or activity
- Individuals who merit special consideration because of their accomplishments that bring recognition to the community

- Availability of funds

Process

All funding requests must be submitted on a donation request form which is available at City Hall. Requests will be submitted to the City Council for consideration in accordance with the schedule announced by the City, and generally will be considered collectively (as a group) at the City Council meeting announced for that purpose. Applicants should expect to attend the Council meeting in order to respond to any questions or clarifications which may arise as the result of that discussion. A percentage of budgeted funds may be set aside, at City Council's discretion, for "emergency" requests during the fiscal year.
